

IMPORTANT INFORMATION REGARDING ACADEMIC TEACHING AND RESEARCH OPTION LICENSES

National Instruments ("NI") is committed to providing cost-effective solutions for academic institutions. Your use of the SOFTWARE is governed by the terms and conditions of a separate Software License Agreement that was provided with the SOFTWARE (the "License"). Unless separately defined in this document, capitalized terms shall have the meanings set forth in the License.

This document is intended to describe the different types of Academic Teaching and Research Option Licenses that NI offers, including the term and maximum number of computers the SOFTWARE may be installed on under each license. The applicable terms stated herein are intended to supplement the terms and conditions stated in the License and shall in no way amend or otherwise modify the terms and conditions of the License. **INSTALLING THE APPLICABLE SOFTWARE ON MORE THAN THE SPECIFIED NUMBER OF COMPUTERS IS ILLEGAL.**

An Academic Institution refers to a degree-granting educational institution.

A use will be considered as one for "instructional purposes" if such use meets either of the following criteria: (i) a common exam is given to students at the end of a semester or other academic period and the exam relates (in whole or part) to the students' use of the SOFTWARE or (ii) homework or similar projects requiring the use of the SOFTWARE are used for grading in lieu of an exam.

The license applies to a department, college or campus in a single geographic location and does not extend to an entire university system (for example the University of Texas System) or district and is non-transferable. For example, a department may be a Department of Electrical Engineering; a college may be a College of Engineering and Sciences; and a campus may be the University of Texas at Austin.

The SOFTWARE shall not be used for any commercial or industrial purpose. If your organization desires to license the SOFTWARE for a commercial purpose or other purpose not permitted under the scope of the License, you must enter into a separate license agreement with NI and pay all applicable NI license fees before engaging in such use.

As specified in each License, each of the licenses described below allows home use by faculty and staff for academic instructional purposes or research purposes.

The SOFTWARE may not be installed on student-owned computers. If your organization desires to license the SOFTWARE for student ownership, please contact NI to inquire on licensing of the Student Install Option.

Term Licenses: If you acquire a Term license, it will expire automatically after the corresponding time stated in this product description document. The SOFTWARE may stop working and become unusable unless you pay the license fee. Any use of the SOFTWARE after the license Term expires will violate the terms of the License. To continue using the SOFTWARE, you may renew your Term license to continue using the SOFTWARE for an additional Term by purchasing Software Service for such SOFTWARE.

Perpetual License: If you acquire a Perpetual License, then, subject to the terms and conditions of the License, you will have the right to use the SOFTWARE indefinitely.

Subject to the terms and conditions of the License, this is a one (1) year Term license for the SOFTWARE specified by NI for such part number, which you may use solely for academic research, teaching, and educational purposes in your Academic Institution. This license shall automatically terminate at the end of the applicable one-year Term. You must purchase Annual Maintenance (Software Service) for the SOFTWARE to maintain this license.

The permitted number of installations of the Software depends on the option selected in the applicable purchase order submitted to NI: (i) a Small Research Option permits installation of the SOFTWARE on up to 25 computers, (ii) a Medium Research Option permits installation of the SOFTWARE on up to 50 computers, and (iii) a Large Research Option permits installation of the SOFTWARE on an unlimited number of computers within your department, college or campus of an Academic Institution.

If you purchased the Research Option prior to the change to the Small, Medium, Large license structure, you may use SOFTWARE for unlimited number of users and computers within your department, college or campus of an Academic Institution, depending on the option selected in the applicable purchase order submitted to NI.
